

ORDINANCE NO. 2002-4

AN ORDINANCE ADOPTING SECTION 24-2, SNYDER CODE OF ORDINANCES, 1988, AS AMENDED, RELATING TO WARDS AND BOUNDARIES; AND MAP OF THE CITY LIMITS.

BE IT ORDAINED by the City Council of the City of Snyder that Section 24-2 of Chapter 24 of the Code of Ordinances, as amended, City of Snyder, Kiowa County, Oklahoma, is adopted to read as follows:

Wards and Boundaries

Section 24-2. Wards and Boundaries and City Limits Map.

1. The four(4) wards of the city shall consist of the following area, and as amended from time to time:

- A. **Ward One (1)** consists of all that land or area lying within the limits of the city, and within the following described boundaries: Beginning at the Northwest corner of Snyder city limits (on county section line EW 162), which is the half section line of Section 11, T2N, R17W.I.M., East to "D" Avenue; thence South along "D" Avenue to North boundary line of the right-of-way of the East-West S.L. & S.F. Railroad line; thence East one block along the S.L. & S.F. ROW to "E" Avenue; thence South on "E" Avenue to 6th Street; thence West one block to "D" Avenue; thence South on "D" Avenue to 11th Street; thence West one block to "C" Avenue; thence South one block on "C" Avenue to 12th Street; thence West one block on 12th Street to "B" Avenue; thence North one block to 11th Street; thence West one block on 11th Street to "A" Avenue; thence South one block on "A" Avenue to 12th Street; thence West on 12th Street to Western Sunset Trail; thence on Western Sunset Trail to the West boundary of Snyder city limits.
- B. **Ward Two (2)** consists of all that land or area lying within the limits of the city and within the following described boundaries: From the intersection of county section line EW 162 and "D":

Avenue (Northeast corner of Ward One), along section line 162 East to the quarter section point of Section 12, T2N, R17W.I.M.; thence South one-half mile along said quarter section line to 6th Street; thence West to the center line of the North-South S.L. & S.F RR line; thence South along the S.L. & S. F. RR centerline to 7th Street; thence West to "I" Avenue; thence South one block to 8th Street; thence West one block to "H" Avenue; thence South on "H" Avenue to 10th Street; thence West on 10th Street to "E" Avenue; thence South one block on "E" Avenue to 11th Street; thence West one block on 11th Street to "D" Avenue (Southeast corner of Ward One).

- C. **Ward Three (3)** consists of all that land or area lying within the limits of the city, which includes all of the areas South of Ward One (1) and West of Ward Four (4).
- D. **Ward Four (4)** consists of all that land or area lying within the limits of the city and within the following described boundaries: From the intersection of "D" Avenue and 11th Street, one block East on 11th Street; thence North one block on "E" Avenue to 10th Street; thence East on 10th Street to "H" Avenue; thence North on "H" Avenue to 8th Street; thence East one block on 8th Street to "I" Avenue; thence one block North on "I" Avenue to 7th Street; thence East on 7th Street to the North-South centerline of the S.L. & S.F. RR; thence one block North along the RR centerline to 6th Street; thence East to the East boundary of Snyder city limits (the North-South quarter section line of Section 12, T2N, R17W.I.M.)

2. References to streets, avenues, highways, roads and rights-of-way in subsection 1 of this section shall mean the centerlines thereof; and reference to the boundary of the city limits shall mean the boundary or limits of the city as it now exists or as it may hereafter exist.

3. That the city limits map identifying the above wards and boundaries adopted May 20, 2002, is now incorporated herein by reference, a copy attached at Attachment "A", and that the city limits boundaries are hereby established as shown on said map.

4. That the effective date of this ordinance shall be May 20, 2002.

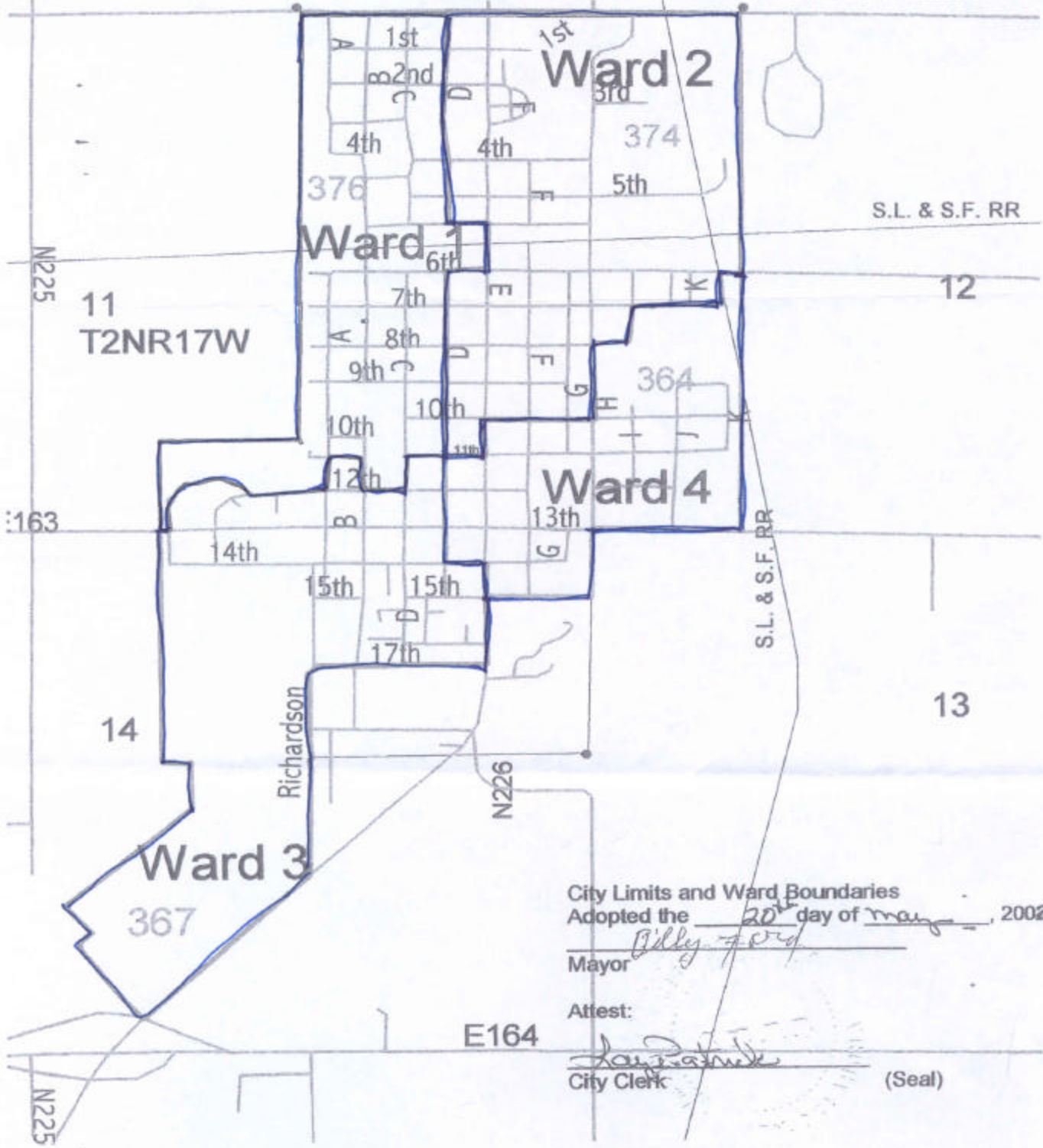
