DUPLICATE OKLAHOMA TITLE APPLICATION

Enclosed is an application for duplicate Oklahoma title. The **record owner(s)** must sign the form and their signature(s) **notarized by a Notary Public**. If you have Power of Attorney to sign on the owner's behalf, the **Actual Notarized Power of Attorney**, or a **Certified Copy of the Power of Attorney**, must also be submitted.

As requested on the application, please list the vehicle identification number of the vehicle, or serial number of the boat or outboard motor. Please also include the current registration decal number.

Either current Oklahoma registration, or evidence of out of state residency, is required before a duplicate title may be issued. Out of state residency may be evidenced by an out of state registration for the vehicle/boat/motor, or a utility bill, rental agreement, or out of state driver license in the name of the record owner. If the Oklahoma registration is not current and out of state residency cannot be established, and delinquent Oklahoma registration fees and penalties will have to be remitted, along with an **Oklahoma** insurance verification form, in order for the duplicate title to be issued.

The fee for a duplicate vehicle title is **\$11.00**, plus a **\$1.00** mailing fee (**\$12.00 total**). The fee for a duplicate boat or motor title is **\$2.25**, plus a **\$1.00** mailing fee (**\$3.25 total**). Please note, if you are applying for a duplicate title for a boat *and* an outboard motor, *two* (2) duplicate title applications must be completed and *two* (2) title and mailing fees remitted.
