# THREE DAY VOUCHER (DST - 213)

## INSTRUCTIONS

### WHEN IS A PAYMENT VOUCHER TO BE USED?

Use a payment voucher only when there is **NO** pre-collect agreement with the Supplier.

### WHEN IS THE PAYMENT DUE?

The payment of taxes will be due three days from the date the import diversion verification number is assigned or three days from the date the motor fuel entered Oklahoma. The earlier of the two dates determines the official due date of this payment.

### CALLING FOR AN IMPORT VERIFICATION NUMBER.

See the import verification number instruction sheet.

### COMPLETING THE VOUCHER.

#### General Information:

Complete each line on the top portion of the voucher. Be sure to include the dates requested.

#### Listing Gallon Information: (lines 1,2, 3, 4, 5 and 6; columns A and B)

Provide the number of taxable and nontaxable gallons for each product. Line 7 should reflect total product imported.

#### Total Gallons Imported Taxable and Nontaxable

Line 7 - Total line 1 through line 6 to calculate the Total Gallons Imported. (line 1, column A) + (line 1, column B) + (line 2, column A) + (line 2, column B) + (line 3, column A) + (line 3, column B) + (line 4, column A) + (line 4, column B) + (line 5, column A) + (line 5, column B) + (line 6, column A) + (line 6, column B)

#### Calculating Tax: (lines 8, 9, 10, 14, 15 and 16))

Line 8 - Multiply the taxable gallons of gasoline (line 1, column A) by \$0.16 to calculate the tax due.

Line 9 - Multiply the taxable gallons of E85 (line 2, column A) by \$0.16 to calculate the tax due.

Line 10 - Multiply the taxable gallons of aviation gasoline (line 3, column A) by \$0.0008 to calculate the tax due.

Line 14 - Multiply the taxable gallons of diesel fuel (line 4, column A) by \$0.13 to calculate the tax due.

Line 15 - Multiply the taxable gallons of biodiesel fuel (line 5, column A) by \$0.13 to calculate the tax due.

Line 16 - Multiply the taxable gallons of jet fuel (line 6, column A) by \$0.0008 to calculate the tax due.

#### Penalty: (lines 11 & 17)

Calculate any penalty due by multiplying gasoline tax due (line 8), E85 tax due (line 9), aviation gasoline tax due (line 11), diesel fuel tax due (line 14), biodiesel fuel tax due (line 15), and jet fuel tax due (line 16) by 10% if remittance is not received within fifteen (15) days from the due date (see above for due date).

#### Interest: (lines 12 and 18)

Calculate any penalty due by multiplying gasoline tax due (line 8), E85 tax due (line 9), aviation gasoline tax due (line 11), diesel fuel tax due (line 14), biodiesel fuel tax due (line 15), and jet fuel tax due (line 16) by 1.25% if remittance is not received thirty (30) days from the due date (see above for due date). (Interest accrues at 1.25% per month until tax is paid).

#### Calculating Totals: (lines 13 and 19)

Add the tax due to any penalty and interest due and provide the total for each category.

#### Total Paid: (line 20)

Add lines 13 and 19 for the total paid on the voucher.
