## NEW SALES TAX EXEMPTION CARD FOR 100% DISABLED VETERANS

New exemption cards have recently been issued to 100% disabled veterans. Please honor the new card and continue to honor the old card. Below are samples of both the new and old cards.

As a reminder:

- Vendors who have actual knowledge that a consumer is entitled to the sales tax exemption provided to a 100% disabled veteran and who willfully or intentionally refuse to honor the exemption may be fined \$500 per offense.
- The exemption has been expanded to include sales for the benefit of the disabled veteran to a spouse of such veteran or to a member of the household in which the veteran resides and who is authorized to make purchases on the veterans' behalf, when such veteran is not present at the sale. The purchaser is required to furnish their exemption card in order to claim the exemption.

SALES TAX EXEMPTION: 100% Disabled Veteran

Non-Transferable

Pursuant to HB 1547; Which we quote in part "Sales of tangible personal property or services to persons...in receipt of disability compensation at the one-hundred-percent rate and the disability shall be permanent...shall not exceed Twenty-five Thousand Dollars (\$25,000.00) per year per individual."

If the business changes location or ownership or is discontinued for any reason, this permit must be returned to the OKLAHOMA TAX COMMISSION for cancellation WITH AN EXPLANATION ON THE REVERSE SIDE.
